(the “Publisher”); and

(the “Licensee”)

**WHEREAS** the Publisher holds the rights granted under this License

**AND WHEREAS** the Licensee desires to use the rights and the Publisher desires to grant to the Licensee the license to use the rights for the Fee, subject to the terms and conditions of this License.

**IT IS AGREED AS FOLLOWS:**

## **1. KEY DEFINITIONS**

1.1 In this License, the following terms shall have the following meanings:

**Authorized Users:** Those persons who are authorized by the Licensee to have access to the Purchased Content. Authorized Users must be current bona fide faculty members, students, researchers, staff members, librarians, executive or employees of the Licensee, and they access the Purchased content via the Licensee’s Secure Network from within the library premises or from such other places where Authorized Users work or study (including but not limited to dormitories) and who have been issued by the Licensee with a password or other authentication (together with other persons who are permitted to use the Licensee’s library or information service and access the Secure Network but only from computer terminals within the Library Premises).

**Purchased Content:** Includes the electronic (online) editions of the Publishers journals and other publications and the content therein for which the Licensee has paid for on a subscription/yearly basis, that are owned or distributed by the Publisher.

**Electronic Reserve:** Electronic copies of materials (e.g. journal articles) made and stored on the Secure Network by the Licensee for use by students in connection with specific courses of instruction offered by the Licensee to its students.

**Fee:** The Fee set out in Schedule 1 or in new Schedules to this License which may be agreed by the parties from time to time.

**Library Premises:** The physical premises of the library or libraries operated by the Licensee.

**Licensed Materials:** The electronic material as set out in Schedule 1 or in new Schedules to this License that may be agreed by the parties from time to time, including such ancillary materials that are owned or controlled by the Publisher and produced specifically to complement, supplement and support the said electronic material or any part of the same.

**Secure Network:** A network (whether a standalone network or a virtual network within the Internet) which is only accessible to Authorized Users approved by the Licensee whose identity is authenticated at the time of log-in and periodically thereafter consistent with current best practice, and whose conduct is subject to regulation by the Licensee.

**Server:** The server, either the Publisher's server or a third party server designated by the Publisher, on which the Purchased Content are mounted and may be accessed.

**Subscription Period:** That period covered by the volumes and issues of the Purchased Content, regardless of the actual date of publication.

## **2. AGREEMENT**

2.1 The Publisher agrees to grant to the Licensee the non-exclusive and non-transferable right, throughout the world, to give Authorized Users access to the Purchased Content via a Secure Network (for the purposes of research, teaching and private study), subject to the terms and conditions of this License, and the Licensee agrees to pay the Fee.

2.2 This License shall commence at the beginning of the Subscription Period for each of the Purchased Content and shall continue for previously purchased volumes, provided a current year renewal is received. Once a current year renewal is received, access to previously Purchased Content will continue uninterrupted from the start of the original Subscription Period.

2.3 On termination of this License, the Publisher shall provide continuing online access for Authorized Users for previously purchased volumes from date of original purchase.

### **3. USAGE RIGHTS**

3.1 The Licensee, subject to clause 6 of this Agreement, may:

3.1.1 Allow Authorized Users to have access to the Purchased Content from the Server via the Secure Network.

3.1.2 Provide single printed or electronic copies of a single article(s) at the request of individual Authorized Users.

3.2 Authorized Users, in accordance with the copyright laws of the United States and subject to clause 6 of this Agreement may:

3.2.1 Search, view, retrieve and display the Purchased Content.

3.2.2 Print a copy or download and save individual articles or items of the Purchased Content for the Licensee's teaching, learning or training purposes.

3.2.3 Use individual parts of the Purchased Content within learning objects for the Licensee's teaching, learning or training purposes.

3.2.4 Distribute a copy of individual articles or items of the Purchased Content in print or electronic form to another Authorized User or to other individual scholars collaborating with Authorized Users but only for the purposes of research and private study. For the avoidance of doubt, this sub-clause shall include the distribution of a copy for teaching purposes to each individual student Authorized User in a class at the Licensee's institution.

3.2.5 Download a copy of individual articles or items of the Purchased Content and share the same with Authorized Users or other individual scholars collaborating in specific research project with such Authorized Users provided that it is held and accessibly within a closed network that is not accessible to any person not directly involved in such collaboration and provided that it is deleted from such network immediately upon completion of the collaboration.

3.3 Nothing in this License shall in any way exclude, modify or affect any of the Licensee's rights under Copyright Revision Act 1976 as amended subsequently provided that such rights are exercised in accordance with Section 108 of the Act and with the guidelines developed by the National Commission on New Technological Uses of Copyrighted Works (CONTU Guidelines) and published in U.S. Copyright Office Circular 21.

#### **4. SUPPLY OF COPIES TO OTHER LIBRARIES**

4.1 Notwithstanding the provisions of Clauses 3.1 and 3.3, it is understood and agreed that neither the Licensee nor Authorized Users may provide, by electronic means, to a user at another library, a copy of any part of the Purchased Content for research or private study or otherwise.

#### **5. COURSE PACKS AND ELECTRONIC RESERVE**

5.1 For avoidance of doubt, the Licensee may not incorporate all or any part of the Purchased Content in any way, including but not limited to: Course Packs, Electronic Reserve collections or Virtual Learning Environments, without the prior written permission of the Publisher, which may set out further terms and conditions for such usage.

#### **6. PROHIBITED USES**

6.1 Neither the Licensee nor Authorized Users may:

6.1.1 Remove or alter the authors' names or the Publisher's copyright notices or other means of identification or disclaimers as they appear in the Purchased Content.

6.1.2 Systematically make print or electronic copies of multiple extracts or make multiple copies of any part of the Purchased Content for any purpose other than expressly permitted by this License.

6.1.3 Prepare derivative works or download, mount or distribute any part of the Purchase Content on any electronic system or network, including without limitation the Internet and the World Wide Web, other than the Secure Network, except where expressly permitted by this License under clause 3.2.5.

6.1.4 Reverse engineer, decompile, alter, abridge or otherwise modify the Purchased Content or any part of them for any purpose whatsoever, except as expressly provided in this License.

## **7. PUBLISHER'S UNDERTAKINGS**

7.1 The Publisher warrants to the Licensee that the Purchased Content used as contemplated by this License does not infringe the copyright or any other proprietary or intellectual property rights of any person. The Publisher shall indemnify and hold the Licensee harmless from and against any loss, damage, costs, liability and expenses (including reasonable legal and profession fees) arising out of any legal action taken against the Licensee claiming actual or alleged infringement of such rights. This indemnity shall survive the termination of this License for any reason. This indemnity shall not apply if the Licensee has amended the Purchased Content in any way not permitted by this License.

7.2 The Publisher shall:

7.2.1 Make the Purchased Content available to the Licensee from the Server via the Internet access to which is authenticated by INGENTACONNECT. The Publisher will notify the Licensee at least sixty (60) days in advance of any anticipated specification change applicable to the Purchased Content. If the changes render the Purchased Content less useful in a material respect to the Licensee, the Licensee may within thirty (30) days of such notice treat such changes as a breach of this License under clause 10.1.2 and 10.4.

7.2.2 Use reasonable endeavors to make available the electronic copy of each journal issue in the Purchased Content not later than the day of publication of the printed version. In the event that for technical reasons this is not possible for any particular journal, as a matter of course, such journal shall be identified at the time of licensing, together with such reasons.

7.2.3 Provide the Licensee, within thirty (30) days of the date of this License, with information sufficient to enable the Licensee to access the Purchased Content.

7.2.4 Use reasonable endeavors to ensure that the Server has adequate capacity and bandwidth to support the usage of the Licensee at a level commensurate with the standards of availability for information services of similar scope operating via the World Wide Web, as such standards evolve from time to time over the term of this License.

7.2.5 Use reasonable endeavors to make the Purchased Content available to the Licensee and to Authorized Users at all times and on a twenty-four (24) hour basis, save for routine maintenance (which shall be notified to the Licensee in advance wherever possible), and to restore access to the Purchased Content as soon as possible in the event of an interruption or suspension of the service.

7.3 The Publisher reserved the right at any time to withdraw from the Purchased Content any item or part of an item for which it no longer retains the right to publish, or which it has reasonable grounds to believe infringes copyright or is defamatory, obscene, unlawful or otherwise objectionable. The Publisher shall post written notice of such withdrawal.

7.4 Collection and analysis of data on the usage of the Purchased Content will assist both the Publisher and the Licensee to understand the impact of this License. The Publisher shall provide to the Licensee upon written request by the Licensee of such usage data on the number of titles, abstracts and articles downloaded by journal title for the Publisher's and the Licensee's private internal use only. Such usage data shall be compiled in a manner consistent with applicable privacy and data protection laws and the anonymity of individual users and the confidentiality of their searches shall be fully protected. In the case that the Publisher assigns its right to another party under clause 11.3, the Licensee may at its discretion require the assignee either to keep such usage information confidential or to destroy it.

7.5 EXCEPT AS EXPRESSLY PROVIDED IN THIS LICENSE, THE PUBLISHER MAKES NO REPRESENTATIONS OR WARRANTIES OF ANY KIND, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO, WARRANTIES OF DESIGN, ACCURACY OF THE INFORMATION CONTAINED IN THE LICENSED MATERIALS, MERCHANT ABILITY OR FITNESS OF USE FOR A PARTICULAR PURPOSE. THE LICENSE MATERIALS ARE SUPPLIED "AS IS".

7.6 EXCEPT AS PROVIDED IN CLAUSE 7.1, UNDER NO CIRCUMSTANCES SHALL THE PUBLISHER BE LIABLE TO THE LICENSEE OR ANY OTHER PERSON, INCLUDING BUT NOT LIMITED TO AUTHORIZED USERS, FOR ANY SPECIAL EXEMPLARY, INCIDENTAL OR CONSEQUENTIAL DAMAGES OF ANY CHARACTER ARISING OUT OF THE INABILITY TO USE, OR THE USE OF, THE PURCHASED CONTENT. IRRESPECTIVE OF ANY CLAIMS, LOSSES OR DAMAGES ARISING OUT OF ANY BREACH OF THIS LICENSE SHALL IN NO CIRCUMSTANCES EXCEED THE FEE PAID BY LICENSEE TO THE PUBLISHER UNDER THIS LICENSE IN RESPECT OF THE SUBSCRIPTION PERIOD DURING WHICH SUCH CLAIM, LOSS OR DAMAGE OCCURRED. THE FOREGOING LIMITATION OF LIABILITY AND EXCLUSION OF CERTAIN DAMAGES SHALL APPLY REGARDLESS OF THE SUCCESS OR EFFECTIVENESS OF OTHER REMEDIES. REGARDLESS OF THE CAUSE OR FORM OF ACTION, THE LICENSEE MAY BRING NO ACTION ARISING FROM THIS LICENSE MORE THAN SIX (6) MONTHS AFTER THE CAUSE OF ACTION ARISES.

## **8. LICENSEE'S UNDERTAKINGS**

### **8.1 The Licensee shall:**

- 8.1.1 Use reasonable endeavors to ensure that all Authorized Users are aware of the importance of respecting the intellectual property rights in the Purchased Content and of the terms and conditions of this License, and use reasonable endeavors to notify Authorized Users of the terms and conditions of the License and take steps to protect the Purchased Content from unauthorized use or other breach of this License.
  - 8.1.2 Use reasonable endeavors to monitor compliance and immediately upon becoming aware of any unauthorized use or other breach, inform the Publisher and take all reasonable and appropriate steps, including disciplinary action, both to ensure that such activity ceases and to prevent any recurrence.
  - 8.1.3 Issue passwords or other access information only to Authorized Users and use all reasonable endeavors to ensure that Authorized Users do not divulge their passwords or other access information to any third party.
  - 8.1.4 Provide the Publisher within thirty (30) days of the date of this Agreement, with information sufficient to enable the Publisher to provide access to the Purchased Content in accordance with its obligation under clause 7.2.3. Should the Licensee make any significant change to such information, it will notify the Publisher not less than ten (10) days before the change takes effect..
  - 8.1.5 Keep full and up-to-date records of all Authorized Users and their access details (e.g. IP addresses) and provide the Publisher with details of such additions, deletions or other alterations to such records as are necessary to enable the Publisher to provide Authorized Users with access to the Licensed Materials as contemplated by this License.
- 8.2 **SUBJECT TO APPLICABLE LAW, THE LICENSEE AGREES TO INDEMNIFY, DEFEND AND HOLD THE PUBLISHER HARMLESS FROM AND AGAINST ANY LOSS, DAMAGE, COSTS, LIABILITY AND EXPENSES, INCLUDING REASONABLE LEGAL AND PROFESSIONAL FEES, ARISING OUT OF ANY CLAIM OR LEGAL ACTION TAKEN AGAINST THE PUBLISHER RELATED TO OR IN ANY WAY CONNECTED**

WITH ANY USE OF THE LICENSED MATERIALS BY THE LICENSEE OR AUTHORIZED USERS OR ANY FAILURE BY THE LICENSEE TO PERFORM ITS OBLIGATIONS IN RELATION TO THIS LICENSE, PROVIDED THAT NOTHING IN THIS LICENSE SHALL MAKE THE LICENSEE LIABLE FOR BREACH OF THE TERMS OF THE LICENSE BY ANY AUTHORIZED USER PROVIDED THAT THE LICENSEE DID NOT CAUSE, KNOWINGLY ASSIST OR CONDONE THE CONTINUATION OF SUCH BREACH TO CONTINUE AFTER BECOMING AWARE OF AN ACTUAL BREACH HAVNG OCCURRED.

## **9. UNDERTAKINGS BY BOTH PARTIES**

9.1 Each party shall use its best endeavors to safeguard the intellectual property, confidential information and proprietary rights of the other party.

## **10. TERM AND TERMINATION**

10.1 In addition to automatic termination (unless renewed) under clause 2.2, this License shall be terminated:

10.1.1 If the Licensee willfully defaults in making payment of the Fee as provided in this License and fails to remedy such default within thirty (30) days of notification in writing by the Publisher.

10.1.2 If the Publisher commits a material or persistent breach of any term of this License and fails to remedy the breach (if capable of remedy) within thirty (30) days of notification in writing by the Licensee.

10.1.3 If the Licensee commits a willful material and persistent breach of the Publisher's copyright or other intellectual property rights or of the provisions of clause 3 in respond of usage rights or of clause 6 in respect of prohibited uses.

10.1.4 If either party becomes insolvent or becomes subject to receivership, liquidation or similar external administration.

10.2 On termination all rights and obligations of the parties automatically terminate except for obligations in respect of Purchased Content to which access continues to be permitted as provided in clause 2.3.

10.3 On termination of this License for cause, as specified in clauses 10.1.1 and 10.1.3, the Licensee shall immediately cease to distribute or make available the Purchased Content to Authorized Users and shall return to the Publisher or destroy all Purchased Content locally mounted pursuant to clause 3.1.1, except as provided in clause 2.3.



10.4 On termination of this License by the Licensee for cause, as specified in clause 10.1.2 above, the Publisher shall forthwith refund the proportion of the Fee that represents the paid but un-expired part of the Subscription Period.

## **11. GENERAL**

11.1 This License constitutes the entire agreement of the parties and supersedes all prior communications, understandings and agreements relating to the subject matter of this License, whether oral or written.

11.2 Alternations to this License are only valid if they are recorded in writing and signed by both parties.

11.3 This License may not be assigned by either party to any other person or organization, nor may either party sub-contract any of its obligations, except as provided in this License in respect of the management and operation of the Server, without the prior written consent of the other party, which consent shall not unreasonably be withheld.

11.4 If rights in all or any part of the Purchased Content are assigned to another publisher, the Publisher shall use its best endeavors to ensure that the terms and conditions of this License are maintained.

11.5 Any notices to be served on either of the parties by the other shall be sent by prepaid recorded delivery to the address of the addressee as set out in this License Agreement or to such other address as notified by either party to the other as its address for service of notices. All such notices shall be deemed to have been received within fourteen (14) days of posting.

11.6 Neither party's delay or failure to perform any provision of this License, as result of circumstances beyond its control, including without limitation war, strikes, floods, governmental restrictions, power, telecommunications or Internet failure, or damage to or destruction of any network facilities, shall be deemed to be, or to give rise to, a breach of this License.

11.7 The invalidity or un-enforceability of any provision of this License shall not affect the continuation or enforceability of the remainder of this License.

11.8 Either party's waiver, or failure to require performance by the other, of any provision of this License will not affect its full right to require such performance at any subsequent time, or be taken or held to be a waiver of the provision itself.

11.9 This License shall be governed by and construed in accordance with New York law; the parties irrevocably agree that any dispute arising out of or in connection with this License will be subject to and within the jurisdiction of the courts of New York
